The Valley of Ashes

A gray, desolate dump ground between West Egg and New York. It represents the moral and social decay hidden beneath the glittering surface of the Jazz Age. It is where the poor live and where the consequences of the rich’s actions play out.

Gatsby’s Mansion and Parties

The lavish, chaotic parties symbolize the excess and emptiness of the era. The mansion itself is a monument to Gatsby’s desire to impress Daisy. After his death, it is abandoned, showing the ultimate futility of his efforts.
