3. Cash on Cash Return

While cap rate looks at the property as a whole, **Cash on Cash Return** focuses on the actual cash you invest. This is a favorite among investors who use leverage. The formula is:

$$\text{Cash on Cash Return} = \text{Annual Pre-Tax Cash Flow} \div \text{Total Cash Invested}$$

Total cash invested includes your down payment, closing costs, and any initial repairs or renovations. For instance, if

you invest \$100,000 in cash and your annual pre-tax cash flow is \$12,000, your cash on cash return is 12%. This formula is powerful because it tells you how efficiently your cash is working. Many investors set a target cash on cash return, such as 8% or 10%, before they even begin looking at deals. It is one of the most actionable **real estate formulas** for leveraged investors.

4. Gross Rent Multiplier (GRM)

The **Gross Rent Multiplier** offers a quick way to evaluate a property without diving into detailed expenses. It is particularly useful for smaller residential properties. The formula is:

$$\text{GRM} = \text{Property Price} \div \text{Gross Annual Rental Income}$$

A lower GRM suggests a better value because you are paying less for each dollar of rent collected. For example, a property priced at \$300,000 with gross annual rent of \$40,000 has a GRM of 7.5. Compare this to a similar property with a GRM of 9, and the first deal looks more attractive. However, GRM does not account for expenses, so it should be used as a screening tool rather than a final verdict. Use it alongside other **real estate formulas** for a complete picture.

5. Debt Service Coverage Ratio (DSCR)

Lenders love the **Debt Service Coverage Ratio** because it measures a property's ability to cover its loan

payments. The formula is:

$$\text{DSCR} = \text{NOI} \div \text{Total Debt Service}$$

Total debt service includes all principal and interest payments for the year. A DSCR of 1.25 means the property generates 25% more income than needed to pay the debt. Most lenders require a minimum DSCR of 1.20 to 1.25 for commercial loans. If this ratio drops below 1.0, the property is not generating enough income to cover its mortgage, which is a red flag. Keeping an eye on DSCR helps you maintain healthy leverage and avoid overextending your finances.

6. The 70% Rule

This is a simple but powerful rule of thumb used primarily by house flippers. The **70% Rule** states that an investor should pay no more than 70% of a property's after-repair value (ARV) minus the cost of repairs. In formula form:

$$\text{Maximum Purchase Price} = (\text{ARV} \times 0.70) - \text{Repair Costs}$$

For example, if you estimate a home will be worth \$400,000 after repairs, and you expect to spend \$60,000 on renovations, your maximum purchase price would be $(\$400,000 \times 0.70) - \$60,000 = \$220,000$. This built-in margin accounts for unexpected costs, carrying costs, and your desired profit. While not a strict formula like cap rate, the 70% rule is a quick sanity check that seasoned investors use to avoid overpaying. It is one of the most practical **real estate formulas** for fix-and-flip strategies.

7. Loan-to-Value

Ratio (LTV)

The **Loan-to-Value Ratio** is a critical metric for both lenders and borrowers. It compares the amount of the loan to the appraised value of the property. The formula is:

$$\text{LTV} = \text{Loan Amount} \div \text{Appraised Property Value}$$

If you are borrowing \$180,000 on a property valued at \$240,000, your LTV is 75%. A lower LTV means you have more equity and is generally viewed as less risky by lenders. Most conventional loans require an LTV of 80% or less to avoid private mortgage insurance. Understanding LTV helps you structure deals that are attractive to financing sources and protects you from being underwater on a mortgage.

8. Break-Even Ratio (BER)

The **Break-Even Ratio** tells you what percentage of your rental income goes toward operating expenses and debt service. The formula is:

$$\text{BER} = (\text{Operating Expenses} + \text{Debt Service}) \div \text{Gross Operating Income}$$

A lower BER means a larger cushion. Lenders typically look for a BER of 85% or less, meaning the property has a 15% buffer before it starts losing money. This formula is especially useful when analyzing properties in markets with fluctuating vacancy rates. If your BER is too high, a few months of vacancy could push you into negative cash flow.

HOW TO APPLY THESE REAL

Begin with a Simple Spreadsheet
