Brake Certification on Test

This portion focuses on the inspection, diagnosis, and repair of brake systems. It covers hydraulic systems, power assist units, disc and drum brakes, anti-lock braking systems (ABS), and parking brakes. The test emphasizes safety and proper procedures, including brake fluid handling and bleeding techniques. Expect questions about brake line corrosion, pad wear indicators, and the legal limits for brake performance during a state inspection.

Emissions and Safety Certification on Test

The second part of the exam addresses vehicle emissions control systems and general safety inspections. Topics include:

- On-board diagnostics (OBD-II) and check engine light protocols
- Evaporative emissions (EVAP) system testing
- Catalytic converter and exhaust gas recirculation

- Safety items: lights, wipers, tires, steering, suspension, and seat belts

Arrive 15 minutes early with a valid photo ID. No calculators, phones, or reference materials are allowed. The test takes about two hours per section.

6. **Receive your results.** If you pass, your certification is

automatically recorded in the MDOS system. You will receive a wallet card in the mail within two weeks.

COMMON CHALLENGES AND HOW TO OVERCOME THEM
