Under current U.S. tax law, single filers can exclude up to \$250,000 of capital gains from the sale of their primary residence, and married couples filing jointly can exclude up to \$500,000. 4. THE HOUSE HACKING LOOPHOLE: LIVING FOR FREE (OR NEARLY FREE)

House hacking is not a tax loophole per se, but it is a legal strategy that exploits the way housing expenses are treated. The concept is simple: buy a multi-unit property (duplex, triplex, fourplex), live in one unit, and rent out the others. The rental income can cover the mortgage, taxes, insurance, and even generate a profit. The owner enjoys essentially free or very cheap housing while building equity and receiving tax benefits from the rental portion.

The **house hacking loophole** also allows you to use an FHA loan with a low down payment (as low as 3.5%) for multi-unit properties, as long as you occupy one unit. This enables first-time buyers to enter the real estate market with minimal capital. Sweat equity refers to the increase in property value achieved through the owner's own labor, such as renovations, repairs, and improvements.
