UNDERSTANDING THE GILLIAM AUTISM RATING SCALE (GADS)

Autism Spectrum Disorder (ASD) is a complex neurodevelopmental condition that affects communication, behavior, and social interaction. COMPONENTS AND SUBSCALES OF THE GADS

1. **Social Interaction:** This subscale assesses the individual's ability to engage in reciprocal social interactions. It includes items related to eye contact, sharing interests, responding to social cues, and forming relationships with peers. Difficulties in this area are a hallmark of autism.
2. **Communication:** This subscale evaluates both verbal and nonverbal communication skills. It covers areas such as language development, conversational ability, use of gestures, and understanding of social communication. Atypical communication patterns are common in autism.
3. **Stereotyped Behaviors and Repetitive Patterns:** This subscale focuses on restricted, repetitive behaviors, interests, or activities (RRBs). Items include repetitive motor movements (e.g., hand flapping, rocking), insistence on sameness, fixated interests, and unusual sensory responses.
4. **Sensory Sensitivity:** Many later editions include a dedicated subscale for sensory processing

issues. This area looks at unusual responses to sensory stimuli, such as being overly sensitive to sounds, textures, lights, or seeking intense sensory experiences.

Each subscale yields its own standard score, allowing clinicians to see which areas are most affected. The combination of these subscale scores forms the overall Autism Index. This dimensionality is a strength of the **Gilliam Autism Rating Scale Gads**, as it provides a profile of strengths and weaknesses rather than a single, monolithic score.

HOW IS THE GADS ADMINISTERED AND SCORED?

Administering the **Gilliam Autism**

Rating Scale Gads is straightforward but requires careful attention to standardized procedures. The scale is typically completed by a rater who knows the individual well, such as a parent, guardian, teacher, or clinician. The rater is presented with a series of statements describing specific behaviors. - **Complete the rating form:** The rater fills out the form independently, though an administrator may provide verbal assistance if needed.

- **Score the form:** The administrator adds the raw scores for each subscale and converts

them, using the manual's norm tables, into standard scores and percentiles.

- **Calculate the Autism Index:**

The subscale standard scores are combined to produce the overall Autism Index.

- **Interpret the results:** The Autism Index and subscale profiles are interpreted in the context of the individual's history and other assessment data.

Scoring yields an Autism Index with a mean of 100 and a standard deviation of 15 (like many intelligence tests). Scores above 70 are typically considered indicative of autism, with higher scores reflecting greater severity. However, these cutoffs should always be used as

guidelines, not rigid criteria.

WHO CAN USE THE GADS?

The **Gilliam Autism Rating Scale Gads** is designed for use by qualified professionals, including licensed psychologists, school psychologists, speech-language pathologists, and other trained clinicians. While the rating form itself can be completed by any informed adult, the interpretation of scores requires professional judgment and knowledge of measurement principles.
